

**AGREEMENT ASSUMING RISK, WAIVER AND RELEASE OF CLAIMS,  
AGREEMENT NOT TO SUE AND RELEASE OF LIKENESS**

I, \_\_\_\_\_, have made a voluntary decision to be a participant in a Truffle Dog Company LLC (the "Company") seminar/ event/ training ( the "events") and to be taught truffle hunting techniques by the Company. I understand that the Company may take me on to property owned and operated by others (the "Owner/Agent") or public property.

I understand and agree that hunting truffles involves risks including, but not limited to, the risk of personal injury, and/or personal property damage; such risks may be generated by the action or inaction of any employees, representatives, property, or agents of the Company or Owner/Agent; or may occur in a truly limitless variety of ways; AND THAT I VOLUNTARILY EXPOSE MYSELF AND MY CANINE TO SUCH RISK BY ACCOMPANYING, OR PARTICIPATING IN, TRUFFLE HUNTING WITH THE COMPANY.

Further, knowing all these risks, I nevertheless hereby agree to voluntarily assume all risks, both known and unknown, and to release and hold harmless the Company, Owner/Agents, and their respective directors, officers, representatives, employees, agents, and all other associated individuals which/who, through negligence, might otherwise be liable for my damages. I understand by executing this agreement, I agree not to sue the Company or Owner/Agent for any injury resulting to myself or my personal property arising from or in connection with my participation in any Company Events on Owner/Agent property or public property.

I hereby also grant permission to the Company, and its officers, trustees, employees, agents, students, representatives, successors, licensees and assigns to film or electronic (video) form of my image, likeness, or depiction and/or that of my minor children (if applicable). I hereby grant permission to the Company to edit, crop, or retouch such images, and waive any right to inspect the final images. I hereby consent to and permit images of me and/or those of my minor children to be used by the Company worldwide for any purpose, including educational and advertisement purposes, and in any medium, including print and electronic. I understand that the Company may use such images with or without associating names thereto. I further waive any claim for compensation of any kind for the Company's use or publication of images of me and/or those of my minor children (if applicable).

I hereby fully and forever discharge and release the Company from any claim for damages of any kind (including, but not limited to, invasion of privacy; defamation; false light or misappropriation of name, likeness or image) arising out of the use or publication of images of me and/or those of my minor children (if applicable) by the Company, and covenant and agree not to sue or otherwise initiate legal proceedings against the Company for such use or publication on my own behalf or on behalf of my minor children. All grants of permission and consent, and all covenants, agreements and understandings contained herein are irrevocable.

I understand and agree this assumption of risk, release, hold harmless, and release of likeness shall be binding on me, my heirs, personal representatives, successors and assigns.
